CONTRIBUTORY SCHEME.

Rules and Conditions of Membership.

1.—The object of the Scheme is to provide persons of moderate means in times of sickness or injury with free reatment for themselves and their families in the general wards of the Hospital, and with free out-patient treatment and other benefits, on payment of a small weekly or yearly contribution : and to provide the Hospital with a steady annual income to meet the cost.

2.—The Scheme shall be managed by a Committee (appointed by the Council), who shall have the power to amend the Rules and Conditions as they deem necessary, and whose decisions in all matters arising under them shall be final.

 The term "Dependants" shall mean the Member's wife (or bissband), his children (under 16), and other relatives ordinarily resident with and wholly dependent upon him.

4.-The following, subject to their income being within the prescribed limits, shall be eligible as Members, and shall pay contributions, in advance, as stated :-

Benefits.

5.-Members and their Dependants shall be entitled, after a qualifying period of three months from the date of joining, to the following benefits :-

The maintenance and treatment ordinarily provided in the general wards of the Hospital under the Lawr and By-laws and ordinary out-patient treatment, excluding Deep Therapy, Maternity Cases, and Cases for which local authorities have accepted responsibility.

Similar maintenance and Treatment at other Hospitals, when circumstances make it impossible for the patient to be conveyed to the Hospital.

Maintenance at a convaluent home, up to 21/- a week tor a period not exceeding four weeks, when recommend ed by the Hon, Medical Staff,

6.- Upon an increase of income beyond the prescribed limits, membership shall cease at the end of the current year. The Committee reserve the right to enquire into a Member's circumstances at say time.

7.—Application for Membership shall be made upon the prescribed form, which may be obtained from the Local Screetary, or at the Hospital. No application shall be accepted when the applicant (or a Dependant) is in immediate need of treatment.

8.—A Member in arrears in his contributions, and his Dependents, shall not be admitted for treatment until his arrears have been made good, except in the case of accident or serious emergency, and if more than eight weeks in arrears, until a further period of four weeks has elapsed. If more than twelve weeks in arrears, failing an explanation satisfactory to the Committee, his membership shall cease, but he may rejoin as a new Member. Upon rejoining a second time the qualifying period shall be six months.

0.--A Member applying for benefits for himself or his Dependants, except in the case of accident or serious emergency, shall present his membership card, together with a letter or certificate from a medical practitioner.




"...For some time he had suffered from an affection of the head, and had been to Birmingham in the expectation of being operated upon, but it was not thought advisable to carry it out. He was under local treatment until a few weeks ago..."

"Dr Steed, of Staunton-on-Wye, said he had attended the deceased just before he went to Birmingham, and it was by his advice that he went there. He was suffering from a tumour just inside the skull. Witness did not know he had come home, and had not heard from the hospital."

"Mr R. E. Snead, of Lower House, in whose employ deceased had been for 14 years, said [he] was a strong man, but nervous. About twelve months ago deceased fancied that something – a little dust perhaps – had got in his eye, and the pain got worse, and he said he had pains from the front to the back of his head. Deceased consulted Dr. Steed and through was sent to Birmingham Hospital seven weeks ago. Witness went to see him at the hospital, and one of the nurses told him that [he] had been under the X rays three times, but the plates taken by the doctors were not satisfactory and they were to put him under the rays the following day."

Three Herefordshire Tragedies. ACCIDENTAL SHOOTING OF A BROTHER. Sad Affair at Kimbolton.

SHOCKING SUICIDE AT PRESTON-ON-WYE. "...[his wife] said that he had been suffering for some months past, and had been patient. He returned on Thursday, the 2nd inst., and was not any better. The Coroner: Why had they not kept him there?

Witness: He did not tell me but said that he wanted to come home, and he was very depressed. He did not say what the doctors had told him and he walked about most of the time..."

"Mr George Townsend, a juryman, said that he fetched [him] home from Hereford, where he had stayed the night, and [he] said he was very bad. He also said "I'm done for." There was a great difference in him from the time when he (Mr Townsend) took him to Hereford when he went to Birmingham." Hereford. Deceased had said to witness, "I am bad. I am done for," and had cried.

On Tuesday evening witness was called to the deceased's cottage and found the body lying on the floor in the back kitchen on its right side. The gun produced was under the body.."

John Hughes (1860-1937)

At an inquest upon an elderly man, John Hughes, of Preston-on-Wye, and formerly cemetery keeper at Pontycwmmoc, Brigend, a verdict of "Sujcide while of unsound mind" was recorded. Evidence was to the effect that Hughes was seen sitting in a chaff-house at Preston-on-Wye, obviously very ill, and Dr. E. W.
